Hypertension Evidence Academy Report



The overall burden of high blood pressure, also known as hypertension, is greater in eastern North Carolina than other parts of the state. Uncontrolled hypertension can increase the risk of heart attack and stroke, the two leading causes of death for Americans. To explore evidence-based approaches to this important issue, NCnet at UNC with the NC Translational and Clinical Sciences (NC TraCS) Institute and ECARE with the Brody School of Medicine at ECU participated in a daylong meeting in Greenville, NC on Dec. 12 2014

The Evidence Academy on Hypertension brought together community leaders, researchers, clinicians, policy leaders, and public health professionals throughout Eastern North Carolina.
